Tuesday, July 29th, 2025, 11:00 A.M. -- Bretz Memorial Livestock Show Arena

1. The 3 highest scores from a chapter or county will make up the team.

2. Classes to be judged <u>may</u> consist of the following: Beef, Swine, Sheep and Goat (Breeding &/or Market).

3. The contest is open to all 4-H and FFA members, within and outside of Graham County.

4. Graham County 4-Her's should indicate on pre-entries if you plan to participate in the livestock judging contest.

5. Pre-Entries are due on Wednesday, July 2, 2025, by midnight online via FairEntry.

6. The divisions for the contest will be as follows:

A. Senior Division (age 14 and Over)-2 sets of reasons

- B. Intermediate Division (10-13)-1 set of reasons
- C. Junior Division (7-9)-1 set of questions

Agriculture Challenge of Champions

Tuesday, July 22, 2025, 4:00 P.M. -- 4-H Building

(Pizza will be provided afterward -- therefore, each participant who plans to eat will need to pay \$5.00.)

Graham County 4-H and Hill City FFA Members are eligible to participate.

1. Contest will be divided into the following age groups:

Junior (7-10), Intermediate (11-15), Senior (16-19)

2. The Graham County Fair Board, the Agriculture Extension Agent and the High School Agriculture Education Teacher will work together to put on this contest.

3. Please indicate on pre-entries if you plan to participate in the Ag Challenge of Champions contest. Pre-Entries are due on Wednesday, July 2, 2025, by midnight online via FairEntry.

4. Contestants will be furnished with placing cards and any other necessary forms. No contestant will be allowed to have books, notes, or pamphlets or use cell phones during the contest.

5. While the contest is in session there shall be NO COMMUNICATION between contestants or parents or anyone other than the group leader.

Contest Format and Points for Seniors and Intermediates. Juniors' Challenge will be a simplified version.

1. Questions-agricultural/livestock industry.

- 2. Questions-cattle, swine, horses, sheep, goats, dairy cattle and livestock health and production.
- 3. Identify livestock equipment.
- 4. Identify breeds of beef cattle, dairy cattle, sheep, hogs, goats, and horses.
- 5. Identify concentrates and/or roughages.
- 6. Identify retail cuts of meat.
- 7. Identify common crops and weeds.
- 8. Identify agronomic items and tractor parts.

The Overall individual ranking will be determined by the total of each contestant's points earned from the contest.

This contest, held in Graham County, is designed to prepare participants for the opportunity to compete at the Kansas State Fair in the Ag Challenge of Champions Contest. The State Fair contest is held annually for 4-H and FFA agriculture and livestock-oriented youth ages 16-19 years. The Kansas Fairs and Festivals Association will award a **\$2,250 scholarship** to the top two individuals from the State Fair contest.

In the event that there is a tie or the winner does not want to compete at the state fair or is not eligible to compete at the state fair the Graham County Fair Board, 4-H Extension Agent and FFA Advisor will select a qualified 4-H or FFA member to represent Graham County at the State Fair Agriculture Challenge of Champions Contest. At the time of the state fair competition the Graham County winner must be in good standing with school eligibility and within the community. If not, an alternate will be selected to represent Graham County.

4-H / FFA DIVISION

GENERAL RULES AND REGULATIONS FOR ALL 4-H / FFA EXHIBITS

- 1. Only bona fide 4-H / FFA Club Members will be eligible to compete.
- 2. Members may exhibit only in projects enrolled in, except where a club officer exhibits an Officer's Book.
- 3. All exhibits must be the current year's project work.
- 4. May enter projects made at school during the current year.
- 5. Judging will be based on placing exhibits in Blue, Red and White award groups. Purple placing will be given to outstanding exhibits.
- 6. Veterinary Sciences, Clothing, Shooting Sports competition displays, Educational Displays and Booth entries must be in place by 9:00 a.m. on Friday, July 25, 2025.
- 7. All static entries not mentioned in #6 may be brought with the 4-H member. Judging of these items will be on Friday, July 25, 2025.
- 8. All static (indoor) judging will be scheduled. The Extension Office will be sending out the schedule to each family before the day the judging takes place. Entry cards will be available in the 4-H Building. Please attach an entry card to each of your entry(ies) before your scheduled judging time.
- 9. 4-H age is the age of the 4-H'er on January 1 of the current 4-H year. Eligible 4-H members must be 7 years to 19 years; and State Fair 4-H age is 9 years to 19 years old.
- 10. If entries are not up to champion standards or if adequate numbers are not entered, Division Grand and Reserve Champions will not be awarded.
- 11. Overall Champions will be based on the criteria as outlined in each area of award.
- 12. Unless otherwise stated, junior division is ages 7-13, senior division is 14-19. In some other classes junior division is 7-9 years of age, intermediate is 10-13 years of age, and senior is 14-19 years of age.
- 13. Please cash premium checks within 90 days after the issue date. There will not be any checks reissued if not cashed within the 90-day time frame.
- 14. The Graham County Extension Office will hold all premium money until all bills are paid.
- 15. If an entry receives more than one placing (example: a blue and a grand champion), contestants will be paid for the higher premium only.

- 16. An asterisk (*) indicates classes that DO NOT qualify as state entries. See Kansas State Fair Rules for the number of exhibits and details for each area.
- 17. Pre-entry forms are due online via FairEntry by Wednesday, July 2, 2025, by midnight.

18. All grievances must be made in writing using the <u>Graham County Fair Grievance Form</u> and signed/dated by the individual who wishes to submit a formal complaint. Such grievances must state plainly the cause of complaint or appeal and must be submitted to the Grievance Committee Chairman within 24 hours of the occasion of the grievance, accompanied by a \$100 cash deposit. The deposit will be forfeited if the grievance is overruled.

19. Copyright Laws: Exhibitors should avoid using copyrighted materials whenever possible by originating his/her own work. Exhibitors should use with caution a copyrighted and/or trademarked product or service (a brand name, label, or product). The intent of using the copyright or trademark materials for educational purposes such as an exhibit, educational poster/display or public presentation is acceptable under the "Fair Use" (legal use) provision. "Fair Use" is a provision of the current copyright law that allows reproduction without payment or permission of limited portions of a copyrighted work for educational and other public interest purposes. Regardless of the "Fair Use" provision, the inference that a specific name brand product is good or bad inherently or through comparison must be done cautiously, using acceptable research/comparison methods and have a disclaimer that the conclusions are those of the participant and not those of K-State Research and Extension. Copyright and trademark are legal methods used by writers, artists, corporations, and others to protect their original work. Protected items may range from books to music, logos to computer graphics. Copyrighted and/or trademarked materials used in banners, displays, demonstrations, posters or other activities for endorsement or promotion instead of educational purposes will be disqualified and will not be displayed or receive ribbons or premium. The use and inclusion of specific brand names for educational purposes does not imply endorsement or refusal by the Department of 4-H Youth Development, Kansas State University Agriculture Experiment Station and Cooperative Extension Service.

GENERAL LIVESTOCK RULES

- 1. See General Rules for 4-H / FFA.
- 2. 4-H/FFA members may not have more than 2 animals exhibited in any one class of a project, except for Pen of 2 competitions.
- 3. Any animals shown in the Beef Department may only show in one class apart from showmanship. Example: An animal may not be shown in the Second-Year Bucket Calf class and the Market Beef class, but may be shown in Market Beef and Beef Showmanship.
- 4. 4-H/FFA Club Members must accompany, care for, and show their own projects, except where two animals are in the same class.
- 5. Only Graham County 4-H members can assist other members in showing livestock at the Fair.
- 6. All livestock, horses, rabbits and poultry must be in place immediately after each species check-in/weigh-in (9:00 a.m.-1:00 p.m.) on Saturday, July 26th, 2025.
- 7. All market animal entries are to attend vet checks and weigh-in during scheduled time frame for each species of fair check-in. If an animal is within 2% of the minimum or maximum weight limit for that species, they will be allowed one additional weight check within the

parameters of the allotted species time frame. Animals that do not meet minimum or maximum weigh requirements will be allowed to show in showmanship or in the Open Class market show, but not will be allowed to show in 4-H/FFA market class or sell in the Premium Auction.

- 8. Livestock must be bedded down by 4:00 p.m. on Saturday, July 26th, 2025 with shavings or rubber mats. Exhibitors will be responsible for bringing their own pen bedding. ***Bedding will not be available for purchase during the fair.**
- 9. All beef must be brought in from the tie-out area by 8:00 a.m. each morning, and may not be taken to tie-outs until 10:00 p.m. each night. Horses may not be left out to graze for extended periods of time between 8:00 a.m.-10:00 p.m. each day.
- 10. The livestock show order for Sunday, July 27th, 2025 will be as follows: 9:00 A.M. swine show, 30-min. break, goat show, sheep show, 1-hour break, bucket calf, beef and dairy cattle show. Within each species, the order will be: 4-H/FFA showmanship, followed by pee-wee showmanship, 4-H/FFA breeding classes, 4-H/FFA market classes, and will conclude with open class in that species.
- 11. **NEW IN 2025** Each exhibitor is responsible for keeping the area around his/her livestock entry clean and leave the area clean at the end of the fair. The expectation is that 4-H members care for, feed, water, wash, clip and fit their own animal. The assistance of a family member or fellow Graham County 4-H/FFA member (or family member) is permitted with the aforementioned responsibilities. Areas not kept clean will have premiums withheld.
- 12. A Herdsmanship Award will be given to the 4-H/FFA family (or individual if applicable) that has the cleanest livestock and tack-pen areas as well as continuously having adequate water and feed for the animals. Consideration will also be given to creativity and display of posters, ribbons, etc. There will be an anonymous judge each day who makes random visits to the livestock barns, and livestock superintendents/county agent may provide insight to judges. Scores from all three days of the fair will be averaged, the family/individual with the highest average score will be the winner of this award. The family/individual that receives the Herdsmanship Award will have their name placed on the Graham County Fair 4-H Champions' board at the Graham County Courthouse.
- 13. The Livestock Showmanship Contest will be divided into 3 age groups, except bucket calf where there are only 2 age groups. Livestock members should enter this contest by the preentry deadline, Wednesday, July 2, 2025 by midnight via FairEntry. There will be contests for Beef, Swine, Sheep, Dairy Cattle, and Goats. Juniors are 7-9 years old, Intermediates are 10-13 and Seniors are 14-18 years old.
- 14. To exhibit at the Kansas State Fair a 4-H member must be 9 years of age but not yet 19.
- 15. The Superintendents in the Livestock Department will oversee <u>all final decisions</u> made.
- 16. Exhibitors are to display all ribbons or stickers that have been awarded or premiums will be withheld.
- 17. Pre-register for stalls and pens online via FairEntry by Wed., July 2, 2025, by midnight.
- 18. Livestock barns will be open from 6:30 a.m. 11:30 p.m.
- 19. 4-H/FFA Livestock, Horse, Rabbit and Poultry entries may be released at the earliest from 10:00-11:30 p.m. on Wednesday, July 30th, 2025.
- 20. Livestock exhibitors will only be allowed to check-out when the area has been cleaned and cleared through the Superintendents or County Agent.
- 21. Up to \$100 of premium monies and/or Premium Auction Monies will be withheld if the 4-H / FFA Livestock Member does not appropriately help with both clean-up/set-up events:

Tuesday, July 22nd @ 6:00 p.m., and Thursday, July 31st, 2025 @ 8:00 a.m. Each 4-H / FFA Livestock exhibitor must check with the superintendents or extension agent in the livestock department to make sure that their obligations have been met. All 4-H members will be required to check-out with Jenilee Godsey prior to leaving the fairgrounds.

22. All 4-H members who will be exhibiting livestock in the Graham County Fair will be required to complete Youth for the Quality Care of Animals (YQCA) training and certification by June 1st. This may either be completed online or at any in-person training.

Fair Board PREMIUM AUCTION Information

- 1. Intent to Sell forms (neon pink) are due to Jenilee Godsey by **2:00 P.M on Monday, July 28th, 2025.**
- 2. 4-H / FFA members may choose a maximum of 2 livestock projects to be sold at the Premium Auction. Example: 2 Market Beef, 2 Market Pens of 2, 2 Market Swine, and 2 Market Sheep, 1 Beef and 1 Swine.
- 3. First year bucket calves will not be sold at the 4-H Premium Auction, but Market Second Year Bucket Calves (steers and heifers) are eligible for the premium auction if they meet the 1,000 pound minimum weight (second year bucket calves that will be kept as breeding heifers are not eligible for the premium auction).
- 4. Animals who go through the Premium Auction are eligible to be exhibited at the Tri-State Royal, Kansas State Fair, or Kansas Junior Livestock Show. Should an animal go on to one of the aforementioned shows, the change of ownership will formally occur on an agreed upon date after the animal has been shown at the Kansas State Fair (or other show) as stated in a contract signed by the exhibitor, purchaser, and parent. The exhibitor assumes liability of the animal in the interim. In case of death before change of ownership date, the floor price will be reimbursed to the purchaser.
- 5. All animals who participate in the Graham County Premium Auction are REQUIRED to change ownership after the conclusion of the fair. Therefore, any exhibitor with auctioned animals not taken to Kensington Lockers, will have to submit a Change of Ownership form or Kansas 4-H State Show Contract to Jenilee Godsey for proof of change ownership.
- 6. **Premium Auction Buyers "Thank You" -** Each 4-H member will be responsible for bringing a photo of themselves with their animal (photo may have been taken from beginning of project the county fair), for each animal that they are selling in the auction. The photo may be in the format of a printed "Thank You" card, a framed photo accompanied by a handwritten "Thank You" card, or any other means of a printed photo/ "thank you" combination. The Buyer Supporter Plaques will be given to each buyer as they check-out with auction clerks at the conclusion of the auction. 4-H members are responsible for presenting their buyer with their buyer's appreciation photo immediately after their animal has sold and to see if they will be purchasing their animal for meat. This needs to be reported back to the clerk's table, ASAP.
- 7. All auction add-on and premium buyer monies will need to be postmarked no later than August 15th, 2025 so that exhibitors receive their checks in a timely matter. Please help in sharing the word by communicating this with your supporters.
- 8. During the Livestock Premium Auction, a "Premium Auction Meat Buyer Form" will be kept per buyer with each animal purchased listed. Upon checking-out with the clerk's table at the conclusion of the auction, the purchaser will be asked to indicate their desire or passing to

purchase the meat of each animal listed on their form. Purchasers will sign this agreement, and this will be housed in the county extension office as protection for the office, the purchaser and the exhibitor in an instance of misunderstanding.

Kensington Locker

- 1. See General Rules.
- 2. See General Livestock Rules.
- 3. Kensington Locker has agreed to process beef and swine.
- 4. All livestock taken to Kensington Lockers under the Graham County Fair date must meet the following criteria: weighed and tagged at spring weigh-in with a Twin Creeks District 4-H or State Fair EID tags, weighed and exhibited at the Graham County Fair, and meet the minimum weight requirement of that species. This could include animals that are shown in open class if all other criteria are met for each animal.
- 5. Please indicate on pre-entries if you will send livestock to Kensington Locker. This is a courtesy to assist them in coordinating help and space for our animals. Pre-Entries are due on Wednesday, July 2, 2025, by midnight online via FairEntry.
- 6. Each Exhibitor is ultimately responsible to pay for the processing charges at the locker or to find a buyer for his/her animal's carcass.
- 9. Each exhibitor must turn in the locker form (bright green) to the Extension Agent by 2:00 p.m. on Wednesday, July 30th, 2025. If you will be sending your animal to Kensington Lockers, we will need the following information on each animal that is going. If you are not sending anything select the box labeled "No animals to Kensington Lockers" and obtain a "Change of Ownership Form" from Jenilee Godsey:
 - 1.) Tag number
 - 2.) Species
 - 3.) Name, address, and phone number of the person responsible for the payment of the processing at the locker if it's someone other than the 4-H / FFA member. Any livestock without the completed form will not be allowed to leave the fairgrounds at load out on Wednesday, July 30th or Thursday, July 31st.

Livestock Showmanship Guidelines

- 1. All showmanship contests will be held before breeding and/or market classes starting with (Senior Showmanship, 14 years of age or older by Jan, 1 of the current 4-H year; Intermediate Showmanship, 10-13 years of age; followed by Junior Showmanship, 7-9 years of age) in each event.
- 2. 4-H / FFA members must show their own animals in showmanship contests.
- 3. Any 4-H Member who chooses to participate in showmanship of any species agrees to show in the Round Robin Competition if they are chosen to represent their specific species.
- 4. An animal tagged in as a 4-H/FFA animal at spring check-in can be used for showmanship and qualify for Round Robin even if the animal does not make weight and cannot compete in the market 4-H/FFA class.
- 5. Bucket calves will not be eligible for the showmanship division.
- 6. Members should indicate their desire to enter the showmanship contest at the time they pre-

enter their animals for fair on Wednesday, July 2, 2025. Here you will be asked if you agree to participate in Round Robin, if selected to represent your species.

- 7. All animals should be ready to show at time of showmanship class.
- 8. Judges will consider:
 - A. Preparation of animals for showing 50 points
 - 1. Condition of feet
 - 2. Trimming of head, ears, hair, etc.
 - 3. Washing and cleanliness
 - 4. Condition of coat, including gloss, no use of objectionable materials
 - B. Showing of animal 50 points
 - 1. Control of animal by exhibitor
 - 2. Poise and coolness of exhibitor
 - 3. Skill in showing, including:
 - a. continuous attention/alertness
 - b. keeping animal placed to advantage
 - 4. Ability to stand or move the animal as requested by the judge
- 9. All contestants will compete together in each species to determine <u>overall</u> top two showman in each age division.

ROUND ROBIN SHOWMANSHIP

- 1. The top Senior and Intermediate Showmanship winner in Horse, Beef, Swine, and Sheep and Goat will automatically be entered into the contest.
- 2. In the event that a person has won in more than one species, they may choose the species with which he/she will participate. The second place winner in the other species may then participate in the Round Robin, or on down the line until a participant is available for that species.
- 3. During the contest, each Round Robin participant will spend 10 minutes with each species (switching animals after 5 minutes to provide fairness among species). Each showman will show all species of livestock on a rotation basis.
- 4. Each showman will provide the equipment needed to show his/her species of animal.
- 5. An animal tagged in as a 4-H/FFA animal at spring check-in can be used for showmanship and qualify for Round Robin even if the animal does not make weight and cannot compete in the market 4-H/FFA class.
- 6. The top showman in each age division will be determined by the judge by his/her ability to show all species of livestock.

- 3. All Bucket Calf entries must have been weighed and tagged on spring weigh-in date authorized by superintendent and extension agent.
- 4. In case of death loss, the calf can be replaced but will **not** be eligible for the rate of gain award.
- 5. Animals may be divided into two groups if the class is large. To be determined by a livestock superintendent and/or county agent.
- 6. The top two animals in the Junior and Intermediate Bucket Calf classes will be named for Grand and Reserve Grand Champion 4-H Bucket Calf.
- 7. Judging will be based on 4-Her's knowledge of raising the calf, nutrition, care, health, feeding and showmanship. The conformation of the calf will not be judged.
- 8. First year bucket calves will not be sold at the 4-H Premium Auction, but Market Second Year Bucket Calves (steers and heifers) are eligible for the premium auction if they meet the 1,000 pound minimum weight (second year bucket calves that will be kept as breeding heifers are not eligible for the premium auction).

- 4. You may tag up to four head per pen of two at the spring check-in. These heifers must be weaned by the time of spring check-in.

- 10. Market Heifers will be able to participate in the Premium Auction following the same rules as other species.

- 12. All market beef animals sold in the Graham County Premium Auction are REQUIRED to change ownership after the conclusion of the fair. - 2. Purple Ribbons will be given to exceptional entries. The final decision will be made by the judge.
- 3. Registration of Booths must be made to the Extension Office by Midnight, Wednesday, July 2, 2025.
- 4. Booths should illustrate and promote 4-H work.
- 5. Booths must be in place by 9:00 a.m., Friday, July 25, 2025.
- 6. Fair Building will be open Wednesday morning (July 23, 2025) from 8 a.m. to 11:00 a.m. booth set-up.
- 7. Each club is to label its booth with a card that states the name of the club. Each club will maintain its booth exhibit in a clean and orderly manner daily. It is important that someone from the club be designated to check the booth at least once each day; clean it if necessary; and keep the booth in good order.
- 8. Booth sizes are approximately 6' x 6'. The back walls of booth spaces are 5' tall. A height of 6' is permitted; however, a height of 5' is preferred.
- 9. Tacks or staples should be used sparingly in the booth walls. Picture hooks and picture wire or masking tape may be used to suspend charts or exhibit material on the wall. Cellophane tape does not hold well on booth walls and should not be used. Small nails may be used in

the 1" x 2" board along the top and front of the booth. Crepe paper can be used to cover the back and sides of the booth but sheets of corrugated display paper, or similar materials are much better for this.

- 10. Use of brand name products/services in a booth exhibit does not in any way imply endorsements of the company or sponsor, its products or services by the United States Department of Agriculture, Land-Grant University, Extension Service, or the 4-H Youth Program.
- 11. Small groups are defined as 2-3 individuals.

- 7. The constructed entries will be judged by consultation judging on Friday, July 18, 2025, at the 4-H Building. A schedule will be sent out prior to judging the participants.
- 8. All entries will be judged prior to the Fair, but ALL garments must be checked-in between 6:00 and 7:00 p.m. on Tuesday, July 22, 2025, during the set-up of the Fair in the 4-H Building. Entry cards, name labels, and earned ribbons need to be attached to each garment/outfit and made ready to be displayed.

- 9. <u>Recycled Clothing Project</u>-- Item made of at least 50% recycled material (recycled means reusing an existing item in a new way); could be remaking/redesigning a garment, repurposing a clothing item for a new use, etc. Exhibit must include sewing of some kind.

- 1. See General Rules.
- 2. 4-H members must have personally trained and cared for his/her dog.
- 3. Dogs must be pre-entered online via FairEntry by Wed., July 2nd, 2025, by midnight.
- 4. Dogs must be on a leash at all times while on the Fairgrounds.
- 5. Dogs will not be allowed space on the Fairgrounds, but are to be brought to the Fairgrounds, checked-in with the Dog Superintendent 15 minutes before show time, judged, and taken home.
- 6. The dog show will be held in two separate arenas on Saturday, July 19th at the fairgrounds. Dogs must remain on leash and out of the 4-H Building until the Cat Show has been completed.
- 7. Dogs must be cleaned and groomed for the show.
- 8. A soft training collar and leather lead or web lead are to be used for obedience classes.
- 9. Any abuse of dogs in the ring will result in disqualification.

- 10. It will be required that proof of rabies vaccination, signed by a veterinarian, be shown at entry time. It is also recommended dogs have DHL and Parvo-Virus vaccination.
- 11. Any Purple or Blue Ribbon dogs may compete at the State Fair 4-H Dog Show if the 4-H'er is nine years old by January 1st and the dog has earned at least 170 points for obedience or a Purple in Showmanship. Please check deadline for State 4-H Dog Show entries on the Kansas State Fair website at <u>https://kansasstatefair.com</u>.
- 12. No more than one entry in any one class.
- 13. Rules and regulations will follow Kansas 4-H Dog Show Guidelines. Purchase a copy at the Extension Office or find link online at <u>www.twincreeks.k-state.edu</u> under the 4-H Programs Tab, click on "County Fair" and find the Graham County Fair.

SHOWMANSHIP

- 2. Purple Ribbons will be given to exceptional entries. The final decision will be made by the judge.
- 3. Articles that have been in use should be cleaned for exhibit.
- 4. Each exhibit must include a "4-H Electronics & Renewable Energy Information Form" which is available through the Extension Office or at http://electric.engtech4ks.com. This form must be attached to the outside of a 10" x 13" manila envelope.
- 5. A sheet of operating instruction must be furnished for any exhibit not self-explanatory.
- 6. Projects (classes 100, 200, and 300) must be operable using only 110 or 120V AC or battery power. If battery power is required, batteries must be furnished.
- 7. Any project with a complexity of size or electronics must have (a) instructions for assembly and use and (b) equipment available at the time of judging for actual testing of the exhibit.
- 8. No hand dipped solder may be used on exhibits.
- 9. All small engine exhibits should involve engines smaller than 20 horsepower for classes 500, 600 and 700.

Class

Electrical and Electronics

100 - <u>AC Electric Projects</u>—Electric projects with a 110 or 120 V alternating current (AC) power source. Some project examples are household wiring demonstrations, small appliances

extension cords, trouble lights, indoor or outdoor wiring boards, or shop lights. Projects may be a restoration or original construction. The project must be operational and meet minimum safety standards. AC projects must be 110/120 V, no 240 V exhibits are allowed, and must be constructed such that the judge has wiring access to examine the quality and safety of workmanship.

- 200 <u>DC Electric Projects</u>—Electric projects with a battery or direct current power source. This class includes electric kits or original projects. This class also includes demonstration DC powered project. Examples include wiring two- or three-way switches, difference between series/parallel lighting circuits or wiring doorbells switches. All have access to examine the quality of wiring workmanship.
- 300 <u>Electronic Projects</u>—Electronic projects with a battery or direct current power source. This class includes electronic kits or original projects. Examples include radios, telephones, toy robots, light meters, security systems, etc. May be constructed using printed circuit board, wire wrap, or breadboard techniques. Include instruction/assembly manual if from a kit. Include plans if an original project. Projects must be constructed such that the judges have access to examine the quality of wiring workmanship.
- 400 <u>Educational Displays and Exhibits</u>—The purpose of the educational display and exhibit is to educate the viewer about a specific area of the 4-H electrical or electronics project. The display or exhibit should illustrate one basic idea. This class includes any educational displays, exhibits or science fair type projects which DO NOT have a power source, i.e., exhibits, posters, or displays of wire types, conduit types, electrical safety, tool or motor parts identification or electrical terminology. Educational displays and exhibits must be legible from a distance of four feet, using a maximum tri-fold size of 3' x 4'.

Small Engines

- 500 <u>Operation</u>—Exhibit an operable small engine overhauled or rebuilt by the member. Include maintenance schedule for the engine and a brief description of steps taken by the member overhauling or rebuilding the engine. Maximum tri-fold size is 3' x 4'. Engine should contain no fuel in tank or carburetor.
- 600 <u>Maintenance</u>—Exhibit a display that illustrates either 1) Routine maintenance procedures OR 2) Diagnosing and troubleshooting specific problems in an engine. No complete engines, lawn tractors, tillers, chainsaws, etc. are permitted for display, using a maximum tri-fold size of 3' x 4'.
- 700 <u>Display</u>—Exhibit a display, selecting one of the following options: 1) a display identifying different engine or lawn and garden equipment parts or a display showing the function of the various engine or lawn and garden equipment parts; OR 2) a display identifying and explaining the function(s) of different special tools needed for small engine work; OR 3) a display illustrating and providing the results of any one of experiments that are included in the project books. No complete engines, lawn tractors, tillers, chainsaws are permitted for display. Maximum tri-fold size is 3' x 4'. Alternative Energy (A form of energy derived from a natural source, such as the sun, geothermal, wind tides or waves) Note: All exhibits in these classes are limited in size to standard trifold, display boards (36" x 48") and items may not extend beyond 12" from the back board. All displays must be self-standing.
- 800 <u>Educational Display</u>—Create an exhibit that addresses a focused topic related to power generated from a renewable energy source. The purpose of the exhibit is to inform and create awareness.
- 900 Experiment—Display an experiment addressing a problem or question related to power

generated from a renewable energy source. Include hypothesis, background research, variables, a control, data, findings, conclusions, and recommendations for future study.

4-H ENTOMOLOGY

- 1. See General Rules for 4-H.
- 2. Purple Ribbons will be given to exceptional entries. The final decision will be made by the judge.

Class

100 - Collection Class—General Guidelines

- 1. All entries should be submitted in an 18" x 24" x 3.5" wooden display box with a translucent plastic top. Boxes can be handmade or purchased if they are of the correct size and <u>do not have a glass top</u>.
- 2. 4-Hers may choose to use one of two taxonomies:
 - a. Option A: As printed in "insects in Kansas" book or
 - b. Option B: As printed on the "insects in Kansas Book: 2016 Revised Taxonomy," which follows <u>www.bugguide.net</u>.
- 3. Each exhibitor is required to identify each box by placing an identification label bearing exhibitor's name inside of the box. Arrange specimens in the box so it can be displayed lengthwise.
- 4. The number of orders, specimens (and families where required) must be included on the exhibitor's box identification label. Only adult specimens can be used in collection boxes.
- 5. Arrangement of specimens: the preferred method is to arrange the insects in groups or rows parallel to the short sides of the box. Arrangements that run lengthwise of the box are frequently downgraded in judging. Specimens are to be arranged by order in the box, then family where required.
- 6. Two labels will be centered on the pin beneath each specimen. First (closest to the specimen) is the common name label and the second label should include date/locality. Full county name, state abbreviation and collector name on the second label are encouraged (required at State Fair). The specimens should be collected by the exhibitor and should focus on Kansas and neighboring states. Other specimens from the continental United States may be included if properly labeled.
- 7. Emphasis in judging will be placed on the overall variety of insects represented in the collection, accuracy of identification, skill and technique acquired in mounting of specimens, and overall arrangement and appearance of the collection.
- 8. Specimens of soft bodied insects such as aphids, lice, termites, etc. should be exhibited in alcohol filled vials; however, the use of alcohol filled vials should be limited to only those specimens that lose their shape when pinned, since the vials pose a significant hazard to the rest of the collection if they become loose.
- 9. A minimum of 50 species representing at least 7 orders are required.

*200 - Shoebox Collection—10-15 specimens for first year in project.

300 - Notebook Class—General Guidelines

- 1. Individual entries are to be placed for display in a three-ring notebook for competition.
- 2. Identification should follow the taxonomy included in <u>www.bugguide.net</u>.
- 3. Each exhibitor is required to identify the notebook by placing a Title Page in the front of the notebook bearing the exhibitor's name. The number of orders, specimens and families must also be included on the Title Page.
- 4. Species pages should be grouped according to order and should include one page per species.
- 5. Date, common name, full county name, state abbreviation and collector name should be included for each species.
- 6. If a picture is taken on different dates/locations include information for both. A statement describing the host/plant/habitat should be included.
- 7. A divider page is to be placed in front of each order of insects with the order name printed on the tab for the page and on the front of the divider page.
- 8. Note: For the State Fair for ages 11 and older, insects are also to be grouped by family behind each order divider.
- 9. A minimum of 10 insect species representing at least 6 different orders.

400 - Educational Display –General Guidelines

- 1. All entries should be submitted in an 18 x 24 x 3.5-inch wooden display box with a translucent plastic top. Boxes can be handmade or purchased if they are of the correct size and <u>do not have a glass top.</u>
- 2. Information on numbers and kinds of insects is not needed for educational exhibits.
- 3. Displays may consist of specialized groups of insects or their close relatives, or relate to any aspect of their behavior, biology, or ecology.
- 4. Displays should be presented in a clear, concise, and interesting manner.
- 5. Displays should include only work performed during the current year.
- 6. The title of the exhibit should be indicated inside the box.
- 7. The purpose of the project is to learn more about the importance, life cycles, biology, ecology, diversity, etc., of insects and related arthropods. Subject matter can be as varied as the animals themselves.
- 8. Creativity is encouraged!

DEPARTMENT H

4-H FIBER ARTS

- 1. See General Rules for 4-H.
- 2. Purple Ribbons will be given to exceptional entries. The final decision will be made by the judge.
- 3. Fiber Arts is defined as any method of creating a unique design with fiber, fabric, or yarn. This may include making fabric (such as weaving, crochet, knitting, needlepoint); or when existing fabric is changed into something quite different (such as quilting or embroidery or

ethnic art). Ethnic Fiber Arts should use fiber, yarn, or fabric to create the design exhibit. Nontextile (examples include wood, reed, straw, grass, etc.) baskets/pieces should be entered in the Visual Arts Division.

- 4. Ethnic Arts is defined as a Fiber Art/Textile technique that is associated with a specific country or culture. It is a practical skill that was developed to provide basic family needs such as apparel, home furnishings or decorations. It is also defined as a method that has been maintained throughout history and passed on to others, often by observation and by example, such as batik, Swedish huck towel weaving, mud cloth, bobbin weaving, tatting, felted items that are not knitted or crocheted, etc. Members should attach information on the history of the ethnic fiber art, where it was used, by whom, how it was used, short description of the technique, etc.
- 5. When articles which are normally worn as a pair are exhibited, both articles must be shown together. Fasten with yarn.
- 6. Special consideration will be given to articles of original design. 4-H'er should label articles as such.

Class

100 - Crochet: an article (includes felted items)

- 200 Knitting: an article made by hand or knitting machine (includes felted items)
- 300 Needle Arts: an article made by hand using any of the following techniques:
 - a. embroidery and cross-stitch
 - b. needlepoint
 - c. candle wicking
 - d. crewel
 - e. lacework
 - f. applique
- 400 Patchwork or quilted article (can be quilted by someone else)
- 500 Rug Making: a rug made by braiding, latch hook, tying, floor cloth, etc. (finished product should be appropriate for use in the home).
- 600 Spinning: a skein minimum of 10 yards in length
- 700 Weaving: a woven article (Include information about type of loom or process used)
- 800 Ethnic Arts: an article
- 900 Macramé: an article-
- 1000 Fiber Arts Educational Notebook: Share with others what you learned in this project about a particular Fiber Art. Exhibits should be in the form of a notebook or binder. The notebook should include a narrative section describing the fiber art. It should include a clear description of the project, technique, budget, supplies, goals, accomplishments, successes, failures, and your plans in this project in the future. It may include samples of techniques, how-to's, photographs of completed projects, or other ways of educating others about fiber arts. NOTE: A collection of brochures, web pages, patterns, record book forms, etc. does not constitute an educational notebook. Follow copyright laws as explained in the General Rules as you are preparing your exhibit. Name and fiber art covered must be clearly marked in the notebook.

DEPARTMENT I

4-H FOODS—NUTRITION

Superintendent – Beverly Reynolds Assistant— Bev Stafford

- 1. See General Rules for 4-H.
- 2. Purple Ribbons will be given to exceptional entries. The final decision will be made by the judge.
- 3. Complete recipe with ingredients and instructions AND the entry card must be presented to the judge, or the placing will be lowered one ribbon. NOTE: All recipes are to be left with the superintendent.
- 3. For food safety purposes, any food with custard and dairy-based fillings and frostings (ex. cream cheese), raw eggs, flavored oils, "canned" bread, or cakes in a jar, cut fresh fruit or any food requiring refrigeration (ex. bacon) or unbaked exhibit with raw flour (ex. No-Bake cookies) will be disqualified and not judged.
- 4. Alcohol (ex. Wine, beer, and hard liquor) is not allowed as an ingredient in food entries. Entries with alcohol in the recipe will be disqualified and not be judged.
- 5. All baked goods must be left whole and uncut. Small items, such as cookies and rolls, should be the same shape and from the same recipe. Example: 3 cookies, 3 muffins, 3 bread sticks, 1 loaf bread, etc.
- 6. Under baked entries will be lowered one or more ribbon placings.
- 7. All unfrosted cakes should be exhibited in an upright position with the crust showing. The exception is for cakes made with special designs such as Bundt cakes. They should have the top crust side down.
- 8. Attach label to bottom of plate or cardboard. Label templates are available at the Extension Office or make your own with the following information: Class Number, Food Product Name, and 4-H member's Name.
- 9. Any baked product that can be removed from the pan should be placed on a plate, a covered cardboard or disposable container of appropriate size for the exhibit.
- 10. After the food is judged, a whole portion of the exhibit will be kept for display (such as a whole cookie, a whole muffin, a whole slice of bread or cake). The 4-H member then has the option of taking the remaining portion of the product home or releasing it to the 4-H Council for the Bake Sale. The only products that cannot be taken home or sold are the Grand Champions and Reserve Champions, decorated cakes, and food gift package.
- 11. For food safety purposes, any food with custard and dairy-based fillings and frostings (ex. Cream cheese) raw eggs, flavored oils, "canned bread or cakes in a jar, cut fresh fruit or any food requiring refrigeration (ex. Bacon) or unbaked exhibit with raw flour (ex. No-bake cookies) will be disqualified and not judged.
- 12. For food safety purposes, any entries with frostings and fillings must calculate the amount of sugar in the frosting/filling only. Calculation must be attached to entry, or the placing will be lowered one ribbon when judged. Frosting and fillings need to contain more than 65percent sugar for safety. Examples on how to calculate this

percentage are included in the publication located at: https://bookstore.ksre.ksu.edu/pubs/MF3544.pdf

Limit: 10 exhibits/4-H member (no duplicates)

Class

- 101 Junior Non-perishable Food Product
- 201 Junior Educational Exhibit-- Exhibits may be in the form of a poster, notebook or display. Follow copyright laws as explained in the General Rules as you are preparing your exhibit. Take care to select materials that will withstand Fair conditions. No card table displays are allowed. If the exhibit is a poster, it must not be larger than 22" x 28". Displays are not to exceed a standard commercial 3' x 4' tri-fold display board. NOTE: A collection of your favorite recipes in a recipe box or notebook does not constitute an educational exhibit.
- 301 Junior Modified Non-perishable Food Product-- Must be modified from original recipe to nutritionally enhance the food product. Attach an 8 ¹/₂" x 11" page (front and back) that includes original recipe, modified recipe, and narrative to describe modifications made, why modifications were made, and lessons learned such as nutritive value, or changes in appearance, doneness, aroma, flavor, tenderness and/or texture. Example: a standard blueberry muffin recipe that is modified to make it gluten free.

- 401 Junior Food Gift Package-- No alcoholic beverages will be accepted. A food gift package must contain at least 3 different food items (prepared for human consumption), made by the 4-H member, in a suitable container no larger than 18"x18"x18". Prepared food items must have recipes attached with the entry. Additional homemade food items beyond the 3 minimum or purchased items may also be included in the gift basket.
 - On the back of the entry card, answer these questions:
 - a) What is the intended use?
 - b) What food safety precautions were taken during and after preparation?

This entry will count as a non-perishable food product, not as an educational exhibit. Home canned foods must follow Food Preservation rules. Canning jars should not be used for baking per manufacturer's instructions. They could break during baking.

*501 – Junior Decorated Food Item-- MUST BE A FOOD ITEM (not a decorated box). 4-H'er will be judged on decorations only, not on the food item.

*601 – Junior Recipe File-- Note: A collection of your favorite recipes in a recipe box or notebook does not constitute an educational exhibit.

- *701 Junior Flop Project-- This exhibit is a food item that the 4-H'er had planned to take to fair but did not turn out. The judge will talk with the 4-H'er about what the 4-H'er may have done wrong and how to correct the mistake. This class does NOT have a premium and will not be displayed. The purpose is for education only.
- *801 Junior Any Snack Only non-perishable food can be entered. The 4-H'er should also know about nutritional value, cost per serving, and preparation of snacks.

- 2. Purple Ribbons will be given to exceptional entries. The final decision will be made by the judge.
- 3. Recipes and processing methods from the sources below are recommended. Recipes must be from current, tested resources listed below AND MUST BE ADJUSTED FOR ALTITUDE based on your processing location, or it will be disqualified. Processing methods that will be disqualified include open kettle canning, over oven canning, sun canning and using electric multi-cookers. Untested recipes will be disqualified for food safety reasons. Tested recipe sources include:
 - K-State Research and Extension Food Preservation publications
 - Other University Extension Food Preservation publications
 - USDA Complete Guide to Home Canning, @2015
 - So Easy to Preserve, 6th edition, The University of Georgia Cooperative Extension Service

Each exhibit must have an entry card and the complete recipe and instructions presented to the judge, or it will be disqualified. <u>Recipe must include exhibitor name, recipe source, date of publication, and altitude, where food was processed.</u> If using Mrs. Wage's or Ball® mixes, indicate the date the mix was purchased.
- 6. Exhibits must be processed in clean, clear standard canning jars, with matching brand (ex: use Ball® lids on Ball® jars, or Kerr lids on Kerr jars, etc.) two-piece lids. Do not use colored jars, fancy padded lids, fabric over wraps or cozies as they interfere with the judging process. No fancy packs unless recipe states to do 28 so (ex: Pickled asparagus). Jars must be sealed when entered. For food safety reasons, the size of jars used must not be larger than the jar size stated in the recipe (ex: Salsa is canned in pint jars only, no quarts). Note: There are 12- ounce, 24-ounce and 28-ounce canning jars. Use quart jar process recommendations for 12-ounce jars. Use quart jar process recommendations for 24 ounce and 28-ounce jars. 7. Each jar exhibited must be labeled. The label must not cover the brand name of jar. The label must give: Class Number, Product, Altitude where processed, Canning Method (water bath, weighted gauge, or dial gauge pressure method), Process Time, Pressure (psi), Date processed including month and year. Labels can be picked up at the Extension Office or printed off the website: https://www.twincreeks.k-state.edu/
- 8. All Purple Ribbon winners, 9 years of age or older, are eligible to exhibit at the State Fair if there is a class for the product.
- 9. Hole punch the entry card and use a rubber band to attach the entry card and recipe around the top of the jar.

4-H GEOLOGY and LAPIDARY

Superintendent - Dani Roeder and/or Christi Keiswetter

- 1. See General Rules for 4-H.
- 2. Purple Ribbons will be given to exceptional entries. The final decision will be made by the judge.
- 3. The exhibit box should be 18" x 24" x 3 ¹/₂". Plexiglas covers are required, *except for class 100*. Boxes with glass covers WILL NOT be accepted. All specimens are to be arranged across the narrow (18") dimension of the exhibit box, making the exhibit 18" across the top and 24" deep exactly. If a box has a sliding Plexiglas cover, it must be removable from the top. Screws, locks, or other devices that would prevent the judge from removing the cover should not be used. For Lapidary classes 600 and 700 only, the dimension of the box should be appropriate for the display but should not exceed 18" x 24" x 3 ¹/₂".
- 4. Each exhibitor is required to identify each display box by placing an identification label bearing name and the number of specimens in the upper left-hand corner of the Plexiglas cover (inside) and by attaching a label with the same information on the lower right corner of the box (outside). Use clear double-sided tape to adhere gummed labels.
- 5. Exhibitor may enter in both Geology and Lapidary classes.
- 6. Geology specimens should be labeled with the number of the specimen, date collected, specimen name or description, and locality (county only) where collected.
- 7. For the Geology classes, specimens should be mounted in the box by proper groups: rocks, minerals, fossils. Fossils must be identified by the Phylum, Class and Genus level. Genus name is to begin with a capital letter. Species name is all lower case. Genus and species names must either be italicized or underlined, not both. The words "phylum, class, genus" on labels are to be spelled out, not abbreviated. More than one specimen of the same kind of rock or mineral or species of fossil may be exhibited if this duplication represents different geological formations.

Specimen label must show this distinction:

- a) Fort Hays limestone, not just limestone.
- b) Calcite from the Greenhorn Formation, not just calcite.
- c) Phylum: Brachiopoda Class: Articulata Genus: Composita from the Morrill Limestone Member, not just Phylum: Brachiopoda Class: Articulata Genus: Composita.
- 8. All specimens must be collected from locations in Kansas. Out-of-state specimens will not count in the minimum number for the class, nor will they be considered in the judging.
- 9. Lapidary will be judged on the following criteria: workmanship and content (60%); presentation and showmanship (30%); and accuracy of information (10%).

Class

- *100 <u>Shoe Box Collection</u>—The box does not have to be a shoe box but should be about the same size. It should be covered with cellophane or plastic wrap. A standard size geology box may be used. (See rule # 4.)
- 200 Geology-Display at least 15 rocks, minerals, and fossils collected during the current 4-H

- 300 <u>Geology</u>—Display at least 30 rocks, minerals, or fossils, at least 5 each. Fifteen must be collected during the current 4-H year. Exhibit limited to two boxes.
- 400 <u>- Geology Educational Exhibit</u>—Exhibit relating to everyday living, or to a mineral test, a rock formation, geological history, species of a fossil, forms of one mineral, a variation of one kind of rock, archaeological artifacts, or Native American artifacts. Digital formats are accepted. Please have a hard copy for display. Exhibit limited to 4 feet of table space. Care should be taken to use durable materials that will withstand Fair conditions.
- 500 <u>Mineralogy</u>—Display a minimum of 15 mineral specimens collected in Kansas, at least 5 of which have been collected during the current 4-H year. The minerals are to be grouped by mineral class (ex: Carbonates, Oxides, Silicates) and at least 3 classes must be represented. The 4-H'er must use one standard display box (see #4). The specimens must be labeled with the number of the specimen, date collected, name of specimen, county where collected and chemical composition (ex: CaCO3).
- 600 <u>Lapidary</u>—Display at least 5 varieties of polished (tumbled) specimens and 5 varieties of unpolished specimens that have not yet received lapidary treatment. These do not have to be an example of "before and after", nor do they have to be self-collected. Locales must be identified.
- 700 <u>Lapidary</u>—Display before-and-after examples of at least 3 varieties of specimens, at least 2 tumble-polished and 2 unpolished of each. There is no requirement that the 4-H'er collect any of these. Locales must be identified. Lapidary work should be done during the 4-H year.

- 2. Purple Ribbons will be given to exceptional entries. The final decision will be made by the

judge.

- 3. Limit 15 photo prints and one video in Photography.
- 4. Photographs entered must be the result of the current year's project work by the 4-H member. Photos must be taken by the 4-H member.
- 5. Remove white border from the photo print before mounting.
- 6. All photos must be no larger than 8" x 10" and no smaller than 7" x 9", after trimming.
- 7. Photos are to be mounted across the narrow (11") dimension of an 11" x 12.5" sheet of white or cream studio matte board. Photo board may be obtained from the Extension office.
- 8. Photos must be mounted with the top edge of the print 1" below the top of the mount. (The board is always oriented narrow side up). The sides of the print must be equal distance from the two sides of the mount.
- 9. A permanent mount must be made by using photographic adhesive.
- 10. The Extension Office will provide name label(s) that will be placed at the bottom of each photograph entered with instructions.
- 11. No lettering, including dates, is permitted on the front of the mount or on the photograph. No underlay or borders are to be used.
- 12. To protect exhibits from dust and moisture, place mounted photos in protective plastic bags. (Optional) These protective bags are available at the Extension Office.
- 13. On the back of the mount, write the exhibitor's name, address, and location where the photograph was taken. (No required any longer by the State Fair Book)
- 14. The 4-H'er entry form must be matched up with each photography entry when consulting with the judge.
- 15. Improperly mounted photos, oversize or undersize photos or photos with the white borders not removed or lettering (including dates) on the photo, will be lowered one ribbon placing as determined by the official judges.
- 16. Photographs taken with a digital camera and having no more adjustments than exposure, color intensity or correction, one click filter effects, red eye removal, cropping, dodging and burning should be entered in the standard color or black and white classes. HDR photos are to be entered in the standard photo class.
- 17. Digital Composite Image: Finished photo must be created from two or more original sources created by 4-H'er. HDR photos do not qualify for this class. Photos will be judged on photographic merit as well as manipulation technique and process. Ribbon placement will be determined by combining the score of each judging section.
- 18. The black and white class is for black and white prints only. Monochromatic prints, including sepia prints, are considered color photos, and must be entered in the appropriate color photo class.
- 19. Appropriate photo subject matter: Photographic subject matter is expected to follow 4-H standards. For a sense of prohibited subject matter, review the "Kansas 4-H Member Code of Conduct"; in general, if it is not allowable at a 4-H event, it is not allowable in a 4-H photograph at the County Fair.
- 20. *Photos with live subject(s) on railroad right away or taken from railroad right of way property will not be displayed and will be disqualified and not judged.*
- 21. Copyright protections must be observed.

FORESTRY

- 1. All leaf exhibits (except Class 700) are to be mounted on 8½" x 11" heavy stock paper and placed in loose leaf binders. (Magnetic or adhesive filler sheets for photographic prints are recommended). Twigs and fruit collections may be exhibited in whatever manner you choose (maximum exhibit size 3' x 4').
- 2. Name, club, age, and year in project should be on front cover or in a prominent location.
- 3. Leaves should be identified with an appropriate label located near the leaf on the same page. These labels should include (1) The proper common name as listed in the 4H334, "List of Native Kansas Forest Trees"; (2) Location (city and/or county) where collected; and (3) date (day, month, year) collected.
- 4. Divide specimens into the following two sections: Native Kansas Trees and Non-Native Trees.
- 5. New specimens are those specimens collected during the current 4-H year and cannot be a duplicate tree species of previously displayed specimens.
- 6. Group specimens according to the years collected (ex. "old-previous years" and "new").
- 7. Variations of varieties do not count as different species or specimens.
- 8. When replacing previously displayed samples, due to degradation, improper mounting or incorrect identification, the specimen label must also be updated. Replacements do not count as new specimens. Replacements should be displayed in the "old previous" section of the display.
- 9. If you retrieve information for your forestry exhibit, you must include a reference citation to the source.

- 10. In all leaf collections (Class 200 Intermediate Forester), exhibit one complete leaf where possible. If the leaf is too large, exhibit as much as possible. Sketch, in reduced scale, the entire leaf and illustrate where the exhibited portion is from. **NOTE: A "leaflet" is incorrect when displayed as the complete leaf for the tree.**
- 11. All work must show originality. Leaf collections and displays should not closely resemble work done by others in the same club.

- A. Exhibit a minimum of 10 different leaves from native Kansas trees collected within the year. The exhibit can include non-native leaves in addition to the required number of leaf specimens collected from native Kansas trees.

- A. Exhibit a minimum of 30 different leaves (including 10 new specimens) from native Kansas trees. The exhibit can include non-native leaves in addition to the required number of leaf specimens collected from native Kansas trees.
- B. Exhibit a minimum of 15 native Kansas trees showing leaf, twig, and fruit from each species collected. This exhibit must include 5 new leaves, twig, and fruit specimens.
- 400 Advanced (Choose either A or B)
- A. Exhibit a minimum of 40 different leaves (including 20 new specimens) from native Kansas trees. The exhibit can include non-native leaves in addition to the required number of leaf specimens collected from native Kansas trees.
- B. Exhibit a minimum of 20 native Kansas trees showing leaf, twig, and fruit from each species collected. This exhibit must include 10 new leaves, twigs, and fruit specimens.

How A Tree Grows

500 - Entry may include a project notebook with 10 or more seeds collected with pictures showing a germination study or a mounting of a thin section of wood cut from the end of a log or top of stump labeled with information such as kind of wood and age of tree when cut or exhibits an illustration of how a tree grows.

Tree Appreciation

600 - Display: Entry may include research or reporting project notebook with no more than 10 pages based on the exhibitor's selected tree. This notebook may include sketches, drawings, pictures, a story, or any other things which will help tell you about the tree you have selected.

Growing and Protecting Trees

- 700 Display: Entry requires a project notebook talking about project and pictures before,
 - during, and after planting seedlings. Maximum tri-fold size is 3' x 4'.

Tree Culture

800 - Display: Entry requires a project notebook showing your project work and includes pictures of before, during and after wood lot improvement. Maximum tri-fold size is 3' x 4'.

How Forests Serve Us

900 - Display: Entry may include collected wood samples (all or partial) and 500-word essay. Wood sample display to be mounted on poster board or any stiff material no larger than a 3' x 4' trifold. Essay should be displayed in a covered binder.

Educational/Creative Exhibit

1000 - Display: Entry must be related to tree identification or Forestry. The type of exhibit is open (notebook, poster, collection box, etc.) given a maximum tri-fold size of 3' x 4'. Care should be taken to use durable materials that will withstand Fair conditions. This is a good class to exhibit an unusual collection.

- 4. A 4-H'er may enter up to 10 floral exhibits. 4-H'er may enter multiple entries in a single class, classes 2100 and 2200, provided each flower specimen is of a different species. Example: Class 2100 Annual Garden Flower, members may enter sunflowers, zinnias, and marigolds under the same class number.
- 5. 4-H'ers are encouraged to exhibit cut flowers and fresh floral arrangements in disposable containers. If a non-disposable container is used, mark it plainly with your name and phone

number. The Fair Board is not responsible for the loss or damage to any flower arrangements, vases, or containers. Containers cannot be picked up until release time on Thursday morning.

- 6. All floral materials must be grown and/or collected by the 4-H'er. Do not use purchased plant materials. Entries should not take over one square foot of table space.

Small fruits (1/2-pint box): strawberries, blackberries, raspberries, or other similar sized fruits. Tree fruits (five each): apples, pears, peaches, or similar sized fruits.

Grapes (two bunches)

2701 -Junior <u>Small Vegetable Specimen Plate</u> (twelve): example: green snap beans, yellow wax beans, radishes, or other small vegetables.

Photos taken from the same location before, during and after the completion of the project are particularly helpful. 4-H'er may enter up to, but no more than, two different horticulture notebooks.

ASTRONOMY

- 1. Telescopes entered in this division may be built from a kit or by original design. Pre-finished telescopes which require no construction or painting are NOT acceptable exhibits.
- 2. Telescopes are limited to no more than four feet in length. They must be placed on a stationery stand that does not allow the telescope to roll and/or fall over. The stand cannot extend past two feet in length or width.
- 3. Each telescope exhibit must include a "4-H Astronomy Exhibit Information Form," which should be attached to the outside of a 10" x 13" manila envelope. You must also include construction plans (or a photocopy) of the telescope and place it inside the manila envelope.
- 4. Two photographs showing telescope construction and operation are required. Photographs should be mounted on one side of an 8 ½" x 11" page. A brief caption should accompany each photograph. Place photos in the 10" x 13" manila envelope.
- 5. The telescope must be properly assembled and painted with a smooth and uniform finish. Decals, if used, should be attached smooth and tight.
- 6. Telescopes designed by the exhibitor must be original, not a modification of an existing kit.
- 7. Educational displays should be creative and showcase something specific the 4-H member has learned in the astronomy project during the current 4-H year. Copyright laws, as explained in the General 4-H Rules, must be followed. Site your sources of scientific information on your exhibit, when appropriate.
- 8. Notebooks, display boards, and posters; no additional exhibit information is required, no manila envelope is needed for these exhibits.

- 3. Educational display boards, posters, and notebooks should be creative and showcase details about the knowledge learned in the computer project. Value is placed on youth who can demonstrate how their skills have increased while completing the project.
- 4. Notebooks, display boards, and posters, no additional exhibit information is required; <u>No</u> <u>manila envelope is needed for these exhibits</u>, as in some phases of Space Tech.
- 5. Each exhibit will be judged on uniqueness, creativity, neatness, accuracy of material, knowledge gained, and content. An exhibit judging score sheet will be available at <u>www.kansasspacetech.com</u>.

- 6. Project notebooks must be organized in a 3-ring binder.
- 7. If the notebook illustrates the creation, talks about, or shows the result of an app, application, executable, program, or other compiled/interpreted "source code," a copy of the source code should be included. (In other words, if you created an app for a smart phone and you are illustrating that app, you should include the code you used to build the app.). *Failure to include a copy of the "source code" may result in up to one ribbon place deduction*.

- 600 Computer Educational Poster
- 700 Computer Display Board
- 800 Computer Notebook

Computer Systems

The Kansas 4-H SpaceTech Computer Systems portion of the computer project is designed to allow 4-H members to explore how *information* is moved from one part of the computer to the other; how *information* is moved between two or more computer systems (networking); how *information* is stored; or how *information* is acted on (programming).

Any item which is not a notebook, display board, or poster displayed in this class is considered a "computer system" exhibit and <u>MUST</u> follow the rules set forth below.

- 1. All exhibits must be self-contained on a USB drive (thumb drive, flash drive, jump drive, or other any other name for a small USB storage device; the rules will use "USB drive"). This means that a judge can plug in the USB drive into a computer and be able to run the exhibit as described below.
- 2. All revisions of all forms previously released for the SpaceTech division either undated or dated prior to 2015 are void for use and new forms must be obtained and used that are dated by the Kansas State 4-H Office for the current year. <u>Use of old forms will result in the loss of one ribbon placing for exhibits.</u>
- 3. For all computer system entries (those entries not covered by the rules above) the following items are required as part of an exhibit packet:
 - a. A manila envelope with the Computer Exhibit Form attached to the front, this form can be downloaded at <u>www.KansasSpaceTech.com</u>.
 - b. A USB drive labeled with the 4-Hers name, and club; in a way that does not prevent it from being plugged into a computer.
 - c. At least one graphic (picture, screen shot/capture, slide, etc.) of the project must be printed out on an 8.5" X 11" sheet of standard computer paper, placed in a plastic sheet protector, to allow for proper display and recognition. On the back side of the graphic the 4-Her's name and club should be listed.
 - d. Instructions to run any part of the exhibit on the USB drive. (<u>There should be at least</u> three items in your manila envelope: USB drive, graphic and instructions).
- 4. Each exhibit must be accompanied by a "4-H Engineer's Journal". The engineer's journal should be typed. It can either be included electronically on the USB drive (preferred) or printed and placed in the manila envelope.
 - a. The "4-H Engineer's Journal" should start with a dated entry describing what the 4-H member is trying to accomplish/build.

- b. The "4-H Engineer's Journal" should conclude with a dated entry describing what the 4-H member achieved in creating. (The start and end many times will be different. The judges are interested in the journey).
- c. Additional entries in the "4-H Engineer's Journal" should be made as progress occurs describing successes and failures; as well as the steps taken and any sources of information including links used.
- d. Pictures can also be included in the "4-H Engineer's Journal" but should not be more than 50% of the entries.
- e. The "4-H Engineer's Journal" should contain at least one graphic.
- f. The "4-H Engineer's Journal" must be at least 3 pages in length.
- g. An example of a "4-H Engineer's Journal" can be found at <u>www.KansasSpaceTech.com</u>.
- h. The "4-H Engineer's Journal" will comprise 50% of the overall exhibit score. <u>Failure to</u> include a "4-H Engineer's Journal" will result in the exhibit being disqualified.
- 5. If the exhibit is a program, application, app, web site, or requires any coding, the source code must be included on the USB drive.
- 6. Diagrams or decision trees showing the logical flow of the system must be included on the USB drive for all exhibits.
- 7. A set of instructions must be provided to run the computer system/application. These instructions should be printed off and included in the exhibit package and a copy should be included on the USB drive. Instructions should be written as though you were helping a less techy person, (like a grandparent) use the USB drive with a computer. An example of instructions can be found at <u>www.KansasSpaceTech.com.</u>
- 8. 4-H'ers <u>should not assume</u> that the computers in rule #9 have Internet connectivity and that any parts of the exhibit that require Internet access will not work. It is strongly recommended that 4-H'ers test exhibits on a computer with Internet connectivity disabled.
- 9. Kansas 4-H SpaceTech has made available Linux Virtual Machines (VMs) that can be downloaded and used to create projects on such as web servers, networking, and many other projects. For more information on how these VMs can be leveraged or to download them visit <u>www.KansasSpaceTech.com</u>. 4-H'ers are not required to use the VMs in their projects. They are optional.
- 10. All licensing should be adhered to for any software used in the exhibit. Failure to do so will result in a reduction of one ribbon placing.
- 11. The creation of viruses, malware, malicious applications or code, defamatory language or graphics, bullying, or any material that is "mean," "dangerous," or harmful according to the judge's opinion will result in the exhibit being disqualified.
- 12. Pictures or still graphics created are not eligible for entry as a project in this division and should be entered in the appropriate photography division.
- 13. Judging will be based on a score sheet which can be found at <u>www.KansasSpaceTech.com</u>. There are four (4) areas each exhibit will be judged on. They are:
 - a. 4-H Engineers Journal (what I learned to make it work), 50% overall score
 - b. Instructions (how I help others make it work), 25% overall score
 - c. Functionality (does it work), 12% overall score
 - d. Diagrams (and code if applicable) (how I think it works), 13% overall score.

Class—Computer Systems

900 - Computer program, application, app, script, or coded system that is new and unique (not merely a file run in a program, such as a "word document' or a picture drawn in Microsoft

Paint').

1000 - Computer presentation (PowerPoint, web page/site, animated graphics, etc.)

1100 - Single computer system (web server, database server, etc.)

1200 - Networked system consisting of two or more computers.

ROBOTICS

- 1. See general AeroSpace Rules.
- 2. Limit--Each 4-H'er may enter one robot per class.
- 3. Each robot must be free-standing, without the need for additional support in order to be moved or exhibited.
- 4. Robot dimensions should not exceed 2 feet high, by 2 feet wide, by 2 feet deep. Weight may not exceed 15 pounds.
- 5. All electric components of the robot must be adequately covered or concealed with a protective enclosure. Paper is NOT considered an adequate enclosure or covering for electrical components.
- 6. Robots may be powered by an electrical, battery, water, air or solar source only. Junk drawer robots may be powered by a non-traditional power source. Robots powered by fossil fuels/flammable liquids <u>will be disqualified</u>. <u>Robots that include weaponry of any kind will be disqualified</u>. No remote-controlled devices will be allowed.
- 7. Each robot must be in operable working condition. The judges will operate each robot to evaluate its workmanship and its ability to complete the required tasks for this current 4-H year.
- 8. Each exhibitor is required to complete the "4-H SpaceTech Robotics Exhibit Information Form" which is available at the Extension office. This form must be attached to the outside of a 10" x 13" manila envelope. For notebooks, display boards, and posters, no additional exhibit information is required; no manila envelope is needed for these exhibits.
- 9. The exhibit must include written instructions for operation, construction plans, one to three pages of project photographs or a five-minute CD, DVD, or video presentation, and robot programming information, if applicable. This information should be placed inside the 10" x 13" manila envelope mentioned above. The 4-H'er may enter their electronic project listed under the Energy Management Project using Class #300, as well as under the SpaceTech Robotics Project if the 4-H'er so chooses.
- 10. Creativity, workmanship, and functionality will be strong criteria in judging the "Robot designed by Exhibitor" classes.
- 12. Remember to site your sources of scientific information in your exhibit, when appropriate.
- **13**. No cardboard table exhibits will be allowed. Care should be taken to use durable materials that will withstand Fair conditions. (Note: No electricity will be provided at the State Fair).
- 14. Team project notebooks must be organized in a 3-ring binder and should highlight information/roles of each team member, drawings, charts, photographs, goals and objectives of your robotics project, and all robotic competitions your team has competed in during the current 4-H year.

2500 - Robot made from a commercial (purchased) kit

- 2600 Robot designed and constructed by exhibitor. The robot must not be a mere modification of an existing robot kit or plan
- 2700 Programmable robot made from a commercial (purchased) kit.

- 3100 Robotics Educational Poster

ROCKETRY

Exhibit Information for ALL rocketry categories:

- 1. See general Aerospace Rules.
- 2. Limit—Each 4-H'er may enter one rocket per class
- 3. All revisions of all forms previously released for the SpaceTech division either undated or dated prior to 2015 are void for use and new forms must be obtained and used that are dated by the State 4-H Office for the current year. Use of old forms will result in the loss of one ribbon placing for exhibits.
- 4. Relevant documents may be obtained from the Extension Office or from <u>www.KansasSpaceTech.com.</u>
- 5. NAR refers to the National Association of Rocketry and its governing board.
- 6. All NAR documents, with the exception of the "pink book," referenced herein can be found at <u>http://www.nar.org</u>.
- 7. If a fire burn ban is in effect for any county in Kansas, exhibitors in any Kansas County are not required to launch their rocket(s). All requirements for the launching of rockets for the state fair and the documenting of the launching are suspended for the duration of the ban.

Exhibit <u>Definitions</u> for ALL rocketry categories:

- 1 As defined by the National Association of Rocketry (NAR), a scale model is "any model rocket that is a true scale model of an existing or historical guided missile, rocket vehicle, or space vehicle". The intent of scale modeling is, according to the NAR, "to produce an accurate, flying replica of a real rocket vehicle that exhibits maximum craftsmanship in construction, finish, and flight performance". (NAR "Pink Book" 50.1 4-1).
- 2. Adult supervision is defined as being under the direct supervision of someone 18 years of age or older.
- 3. For the purposes of Kansas 4-H SpaceTech a high-powered rocket is defined as a rocket that meets any of the following criteria:
 - a. It is 2 inches or greater in diameter (not including fins) <u>and</u> taller than 3 feet (36 inches including fins).
 - b. Weighs more than 3.3125 pounds (53 ounces or 1500 grams) at the time of launch.
 - c. Uses an 'E' engine or larger to launch (2D's, 4C's, 8B's, etc.).
 - d. The total impulse of all engines used in the rocket is greater than 20.01 Newton-seconds of thrust.
 - e. Models powered by rocket motors not classified as model rocket motors per NFPA 1122, e.g.:
 - i. Average thrust in excess of 80.01 Newtons

- ii. Contains more than 2.2 ounces (62.5 grams) of propellant and are limited to only H and I motor.
- 4. High power certification is defined as having successfully completed a certification program for high-powered rocketry through the NAR and maintaining that certification. This applies to all membership levels in the NAR. Specifically, the "Formal Participation Procedure" for the "Junior HPR Level 1 Participation Program" as outlined by the NAR.
- 5. NAR rules for launching and construction of all rockets are assumed to be used by all 4-H SpaceTech exhibitors and will be considered during judging.
- 6. For the purposes of Kansas 4-H SpaceTech, NO rocket may be launched using engines totaling more than an 'I' impulse engine or 640 Newton-seconds of total thrust.

Exhibit <u>Rules</u> for ALL rocketry categories:

Purpose: These rules apply to how rockets are to be displayed at the fair and what those displays should and should not contain. These rules apply to all rockets displayed in the SpaceTech division.

- 1. The report that accompanies the rocket must be limited to the 4-H SpaceTech Rocket Exhibit Information Form which is affixed to a 10" x 13" envelope. This envelope should NOT be attached to the rocket stand or rocket. This may be downloaded from <u>http://www.Kansas4-H.org/</u>. *Any rocket exhibit not including this completed envelope will receive an automatic participation ribbon*.
- 2. Plans (or a photocopy) must be placed inside the envelope.
 - a. This includes original design rockets.
 - b. If a rocket kit has been modified structurally, notations need to be given indicating the changes made, either by notations on the "Rocket Exhibit Information Form" or by placing notes in the plans.
- 3. One or more photographs of the rocket at the launch site are <u>required</u>.
 - a. Photographs showing the rocket at the moment of ignition are preferred.
 - b. Photographs must be mounted on one side of 8 $\frac{1}{2}$ " x 11" page(s).
 - c. There must be at least one page of photos and no more than five pages of photos.
 - d. Include at least one photo showing rocket construction, preferably with the exhibitor included.
 - e. Do not include photos of members catching their rockets as they return to earth. This is an unsafe practice, and we do not recommend or condone this practice.
- 4. To exhibit in this division:
 - a. The rocket must have been flown.
 - b. Support rods must not extend past the tip of the highest nosecone on the model.
 - c. Support rods must remain in the upright position, 90 degrees to the display base, <u>do not</u> <u>angle</u>. <u>If support rods are not perpendicular to the base, the judge should deduct two</u> <u>ribbon placings</u>.
 - d. No model may be submitted on a launch pad.
- 5. Launches should not be conducted in winds above 20 mph and will constitute a disqualification of rocket exhibit.
- 6. All rockets must have a safe method of recovery, e.g., parachute, streamer or tumble recovery. <u>Any rocket without a recovery system will be disqualified.</u>
- 7. The altitude achieved by the rocket is to be determined using a method other than estimation. Examples of accepted methods include an altimeter, computer software, range finders, etc. If

additional space is needed to show calculations of how the altitude was achieved one additional page may be added to the rocketry information pack.

- 8. Flight damage is to be documented by the participant on either the construction plans or the "4-H SpaceTech Rocket Exhibit Information Form".
- 9. The judging of flight damage is to be secondary to all other aspects of the model and only then may it even be considered. However, under <u>no circumstance</u> may flight damage be grounds for disqualification.
- 10. Engines and igniters, under any circumstance, <u>ARE NOT</u> permitted with the exhibit and constitute an <u>immediate disqualification</u>.
- 11. If an engine becomes stuck, jammed, wedged, or in any other way permanently affixed in or to a rocket and cannot be removed from the rocket, the rocket will be subject to <u>immediate</u> <u>disqualification</u>. This is because it is not possible to make a full and immediate assessment of the safety of the rocket when it is being judged and safety is paramount.
- 12. Engines may not be used as display stands hollowed out or otherwise. This is a significant change from previous year's rules. Engines used as a display stand will be subject to <u>immediate disqualification</u>.
- 13. Rocket engines should not be used to join multi-stage rockets together.
 - a. Multi-stage rockets can be displayed without having the stages connected.
 - b. The different stages must be included to complete the rocketry exhibit, <u>incomplete</u> <u>exhibits will be deducted at least one ribbon placing</u>.
 - c. Use of any engines to join the stages together will be subject to <u>immediate</u> <u>disqualification</u>.
- 17. Multi-stage rockets can be flown using just the final stage and be considered fully flown.
- 18. If a safety violation is noted by the judges, superintendent, or other staff, the exhibitor's rocket, at the judges' discretion, <u>will receive a participation ribbon</u>. All necessary information will be given to the NAR and TRIPOLI for investigation and possible revocation of membership.

Purpose: These rules apply to the construction of all rockets displayed in the SpaceTech division.

- 1. Rockets are to be properly assembled according to the assembly instructions.
- 2. Beginner kits with prefabricated fin assemblies and pre-finished rockets requiring no painting are not acceptable.
- 3. Plastic snap together fins and prefabricated fin assemblies that **do not** require fin alignment are not acceptable.
 - a. This rule does not apply to plastic fins that must be manually aligned and does not utilize a fin alignment mechanism, including, but not limited to fin alignment rings or spacing blocks.
 - b. This rule does not apply to fiberglass, Kevlar, extruded foam, composite, or wood fins; especially when used for "through-the-wall" fin attachment techniques that are common in larger rockets.
 - c. In addition, plastic parts for decorative and mechanical purposes (i.e., decorative nozzles and moving landing struts) are not considered fins and can consist of plastic. Decorative nozzles, etc. need to be securely fastened and not pose a safety hazard.
- 4. Angles of fins must fall within a plus or minus 2-degree variation using an approved fin alignment guide (such as KSSTAC10). An official fin guide is available from www.KansasSpaceTech.com.
- 5. Fins should be rounded or streamlined to reduce drag.

- 6. Fins and body tubes are to be sealed with <u>sanding sealer</u> and/or <u>primers</u> to <u>eliminate</u> the appearance of body grooves and wood grain.
- 7. Fins and launch lugs are to be filleted to reduce drag and properly secure them to the model.
- 8. Any seams on plastic parts are to be sanded smoothly.
- 9. Body tubes/airframes/engine mounts can be made from suitable materials, including, but not limited to reinforced paper, cardboard, phenolic resin, specialized polymer resins, fiberglass, Kevlar, or other suitable structural materials. However, foam may not be used for external body or other external rocket parts.
- 10. The nose cone fits snugly but still allows for easy removal.
- 11. Exhibits must be <u>uniformly</u> painted and <u>smoothly</u> finished or <u>finished</u> as per rocket instructions, and have decals applied smoothly.
- 12. Nonstandard surfacing (such as textured paint) may be used if directed by the instructions, this includes scratch-built rockets.
- 13. Models may not be judged based on their paint scheme (colors and placement on the rocket), with the exception of rockets that fit the definition of a "scale model." All other rockets do not have to follow the suggested paint scheme, allowing the 4-H'er to display maximum creativity in the finishing of their rocket.
 - a. Under no circumstances is the weight given to the paint scheme to be sufficient, by itself, to move the model from one ribbon placing to another.
 - 1. "Scale models" may be judged based on their paint scheme. <u>The judge may deduct up to</u> <u>one ribbon placing for not following the paint scheme</u>.
 - 2. Scale Model Rockets are to be finished and completed with a majority (greater than 70%) of decals.

Model Rocketry Guidelines (ages 7 and up):

Purpose: Model rockets are small-to-medium sized rockets that can be purchased at hobby stores or are small-to-medium sized model rockets that an individual(s) builds from parts like those found in model rocket kits.

- 1. Rockets classified as high powered may not be entered in this category.
- 2. Each rocket must be able to stand freely by itself or be supported by a solid base, not to exceed 4-1/4" thick and 8" square. The 4-H'ers name, county or district, and age must be labeled on the top of the base. Rod materials should be sturdy, and not made of flimsy materials, such as coat hangers.
- 3. If the model rocket is greater than 4' tall it can be displayed without a base or displayed parallel to the ground with up to three notched blocks not to exceed 4" in height width and depth. 4-H'ers name, county or district, and age must be labeled on the top of the base.
- 4. All 4-H'ers must comply with the NAR Model Rocket Safety Code that is in effect as of October 1st of the current 4-H year. However, if there is a modification in this code, the SpaceTech Action Team may review and implement the modified code.

Original Design Rocket Guidelines (ages 11 and up):

Purpose: To allow for youth to develop their own rockets (model and high powered) in a safe manner that displays maximum craftsmanship.

- 1. Original design rockets cannot be a modification of a pre-existing kit and must be of original design.
- 2. Original design rockets must be designed by 4-H'er(s).

- 3. Original design rockets must include detailed instructions, so that someone could construct the original designed rocket just like a kit purchased at a store. Instructions can be as many pages as needed to convey full and complete construction techniques.
- 4. Original design rocket instructions should not include copies of instructions in part or in whole from existing kits.
- 5. For a rocket entered in the original design classes, describe in the summary how the rocket was tested for stability prior to flying. Swing testing of the rocket is required. Must include documentation.
- 6. Up to four additional pages can be added to the rocketry information pack detailing the test(s) performed to ensure stability. 4-H'ers are strongly encouraged to provide as much detail as possible. Failure to provide adequate written documentation will result in a disqualification.

Alternative Skins (ages 14 and up):

Purpose: Alternative skins are an advanced construction technique that allows the builders of model rockets to display maximum design and creativity in their models. Alternative skins are thin coverings over a supporting skeleton that serve as the finish of a rocket as opposed to painting.

Construction and Operating Rules and Guidelines:

- 1. The General exhibit rules for ALL categories apply.
- 2. Use of alternative skins used for model aircraft is permitted on rockets of original design provided adequate provisions are made to prevent the rocket from catching fire during all phases of flight.
- 3. When used in construction these alternative skins should not be used as primary structure for the rocket. The rocket should still be of sound design and construction to ensure safety for personnel performing launch activities as well as others who are in the nearby vicinity.

Types of Covering:

- 1. Plastic shrink type coatings used for radio control model aircraft are permitted. These can be obtained from various manufacturers and hobby suppliers.
- 2. Other types of fabric coverings such as cloth types using coatings for stiffness are permitted if all the rules set forth above are met.

Quality of Finish:

When the above finishes are used the following judging criteria will apply in addition to those for judging other rocketry divisions.

- 1. Seams and transition areas will be uniform even when they are needed in the construction.
- 2. Gaps and holes are not permitted in the covering, especially where the fins or other stabilizing devices meet the main body of the rocket.
- 3. Omission of these skins from the bottom of the rocket is permissible. Paints and other types of coatings currently used for rocketry may be substituted in these areas.
- 4. Alternative skins in this section may also be used in conjunction with paints on the rocket. However, care shall be taken to ensure that edges of the alternative skins will not peel off in flight.

High Power Rocketry Guidelines:

Purpose: To allow for improved safety and judging of rockets that meet the requirements of 4-H high power rockets.

- 1. Exhibitors must be at least 14 years of age by January 1 of the current year.
- 2. The rules for ALL categories apply.
- In addition to the information packet completed for all rockets, a "High Power Information" form is to be completed and placed inside of the information packet. This May be downloaded from <u>http://www.Kansas4-H.org/</u>. Click on KSF Packet link.
- 4. The NAR High Power Rocket Safety Code applies to the construction and launching of all rockets displayed in this division. As such all 4-H'ers must comply with the NAR High Power Rocket Safety Code that is in effect as of October 1st of the current 4-H year. However, if there is a modification in this code the SpaceTech Action Team may review and implement the modified code.
- 5. All rockets in this division are to be launched under adult supervision by the 4-H member who constructed the rocket.
- 6. If a rocket is launched using an engine(s) that has 160.1 ('H' engine or equivalent number of smaller engines) Newton's-seconds or larger, adult supervision must be provided by an individual having at least a level 1 high power certification.
- a. The 4-H member should also hold or be attempting to attain their level 1 high power certification, and should include supporting documentation of such (a copy of Level 1 card is sufficient).
- 7. If according to Federal Aviation Regulations Part 101, a waiver is required to fly the rocket, a copy of that waiver is to be attached to the "High Power Information Form". In the case where the launch was a public event a substitute for a copy of the waiver is the Range Safety Officers' (RSO's) contact information.
- 8. High Power Rockets may be displayed without a supporting stand. If a supporting stand is used, it is not to exceed 4-1/4" thick and 8" square. The 4-H'er's name, and age must be labeled on the base.

Rocketry Educational Exhibits – Posters, Notebooks and Display Boards

Purpose: To allow 4-H'ers to explore rocketry and aerospace outside the bounds of traditional modeling.

- 1. The General Exhibit rules for ALL categories apply.
- 2. For notebooks, display boards, and posters, no additional exhibit information is required; no manila envelope is needed for these exhibits.
- 3. Exhibits may not consist of only a rocket, but must contain substantial supporting educational material in the form of posters, notebooks, or display boards, etc.
- 4. Displays should be creative and showcase something specific you have learned in the Rocketry project during the current 4-H year.
- 5. Follow copyright laws, citing all sources of information in a standard notation on the "4-H Educational Rocketry Exhibit Information Form". Additional pages can be added inside the Information Packet and should be labeled "Citations". Site your sources of scientific information on your exhibit, when appropriate.
- 6. "Construction Kits" that are part of educational displays must be contained in cases (tackle boxes, sealable containers, etc.) that may not be larger than 1' X 2' X 2' and must have a latch which securely keeps all components contained in the "Construction Kits". Other components are to adhere to appropriate dimensions as stated elsewhere.
- 7. Rocketry Educational Project notebooks must be organized in a 3-ring binder.
- 8. <u>Engines and igniters ARE NOT permitted with the exhibit and constitute an immediate</u> <u>disqualification</u>. This is for safety reasons and includes both spent and live engines.

- 9. Exhibits should possess the following qualities (in no particular order):
 - a. A Central theme.
 - b. What you want others to learn.
 - c. Be designed and constructed in a manner befitting the exhibit.
 - d. Be something you are interested in.
 - e. Be related to model or high-power rocketry.
 - f. And those characteristics described above.

Rocketry Class

- 3201 Junior Rocket made from kit. Include plans.
- 3301 Junior Rocket designed by exhibitor; not merely a modification of an existing kit includes original plans.
- 3401 Junior Rocket designed by exhibitor that uses alternative skins, not merely a modification of an existing kit. Include original plans.
- 3501 Junior Rocket designed by 2 or more exhibitors, not merely a modification of an existing kit. Include original plans.
- 3601 Junior High-power rocket made from kit or original design.
- 3701 Junior Rocketry Educational Display
- 3801 Junior Rocketry Notebook
- 3901 Junior Rocketry Poster
- 3202 Intermediate Rocket made from kit. Include plans.

- 2. Projects with missing or insufficient plans will be lowered one ribbon placing (i.e., a blueribbon exhibit will receive a red ribbon).
- 3. The use of materials other than wood should be kept to a minimum.
- 4. Projects that have unsecured glass, i.e., glass shelves, glass top of a coffee table, etc., should not be brought to the fair. Glass that is secured in the project, i.e., glass front of a gun case or cabinet, etc., is permissible since it cannot be easily removed.
- 5. The entry card, plans and all other paperwork should be secured for the project in some way. Tape is usually not adequate to accomplish this. It is recommended to use a zip top plastic bag with a hole punched through it and using string to tie this to the exhibit.
- 6. Refinished/ repaired furniture should be exhibited in Home Environment Class 4400 Single Exhibit.
- 7. Projects made from pre-cut kits are not allowed.
- 8. In judging woodwork articles, consideration will be given to: Workmanship, including accuracy to the plan; Design; Choice of wood; Suitability and quality of finish; and Usefulness.

FOOD PRESERVATION

- 1. See Open Class General Rules.
- 2. All exhibits must be preserved within the last year.
- 3. USDA recommended methods of processing must be used.
- 4. All preserved foods must be in regular, standard-size canning jars and where three jars make up a collection, jars and lids must be same brand name. Jelly must be exhibited in standard or wide mouth half-pint, or pint jars with rings no paraffin. Rings must be free of rust and removable.
- 5. Each jar must be labeled with uniform labels one inch from base of the jar but must not cover the brand name. Label must show Class, Name of Product, Canning Method, and Exhibitor's Name. Labels may be picked up at the Extension Office.
- 6. Entry cards need to be attached to the jar with a string around the neck of the canning jar.
- 7. No colored jars allowed but colored lids are accepted.

- *1700 <u>Foods for a quick meal</u>. Three jars of different foods that might be kept on hand for a quickly prepared meal. Include menu on a 3" x 5" card.
- *1800 <u>Foods for a company dinner</u>. Three jars of different foods that might be used in a more elaborate meal for company. Include menu on a 3" x 5" card.

FOODS AND NUTRITION

- 1. See Open Class Rules
- 2. All exhibits must be homemade by the exhibitor.

3. All rolls, muffins, and cookies should be placed on a 6-inch disposable plate. Place cakes and breads on covered cardboard that is 1-inch larger than the product. Pies, cobblers, crisps should be exhibited in a disposable aluminum pan, placed in a plastic bag.

4. All exhibits should be labeled on the bottom of the covered cardboard, disposable plate, or aluminum pan. It should contain: Name of Product, Class, and Exhibitor's Name. Labels are available at the Extension Office.

- 5. All exhibits must have an entry card attached to the outside of the bag.
- 5. All exhibits must be baked, and products must be uncut and whole.
- 6. All unfrosted cakes should be exhibited in an upright position with crust showing, except for those cakes with special designs such as Bundt.
- 7. Any class in which three of the products are exhibited must be of the same recipe and the same shape and size. (cookies, muffins, brownies, etc.)
- 8. For food safety purposes, any food with custard and dairy-based fillings and frostings (ex. Cream cheese) raw eggs, flavored oils, "canned bread or cakes in a jar, cut fresh fruit or any food requiring refrigeration (ex. Bacon) or unbaked exhibit with raw flour (ex. No-bake cookies) will be disqualified and not judged.
- 9. For food safety purposes, any entries with frostings and fillings must calculate the amount of sugar in the frosting/filling only. Calculation must be attached to entry, or the placing will be lowered one ribbon when judged. Frosting and fillings need to contain more than 65percent sugar for safety. Examples on how to calculate this percentage are included in the publication located at: https://bookstore.ksre.ksu.edu/pubs/MF3544.pdf
- 10. After the food is judged, a whole portion of the exhibit will be kept for display (such as a whole cookie, a whole muffin, a whole slice of bread or cake). The exhibitor then has the

option of taking the remaining portion of the product home or releasing it to the 4-H Council for the Bake Sale. Tell the Superintendent what your wishes are when you enter the product. All Preserved Food will remain on display and not be sold. The only products that cannot be taken home or sold are the Grand Champions and Reserve Champions, and decorated cakes.

- 11. Explicitly 4-H members cannot enter exhibits in Open Class that are duplicates of the same recipe used in the 4-H Division. You must use a different recipe.
- 12. Enter vinaigrettes under the arts and crafts section due to food safety concerns.
- 13. <u>Educational Exhibit</u> for classes can be a poster, notebook or other display showing and describing something learned, a project actively done, a food-nutrition community service program, etc.-- should relate to things that have been done in the project.
 - Classes will be evaluated 60% on nutrition information and 40% on poster appearance.
 - All classes are open to ages 18 and younger.

Special Rules: In addition to the Open Class General Rules governing all exhibits, the following rules will be strictly enforced by the Superintendents of the department:

All open class rabbit, poultry, horse and livestock (beef, sheep, swine, goats and dairy) entries are due in the FairEntry System by 5:00 p.m. on Wednesday, July 23rd, 2025. No late or day of show entries will be accepted.

1. All exhibition animals must be owned by the exhibitor.

2. In animal classes, duplicate entries will be received; that is an owner may try for a certain award with two or more suitable animals.

3. No exhibitor may exhibit more than two breeds of any class of livestock.

4. First premium exhibits in the various classes are in line to compete in their respective classes for Champion.

5. Open class swine, goats and sheep will be checked-in on Sunday, July 27th, 2025 between 8:00-8:30 a.m. Open class bucket calves and beef will be checked-in on Sunday between 11:30 a.m. and 12:00 p.m. Open class animals must have current health certificate signed by veterinarian at time of open class check-in, OR must be inspected by veterinarian at time of 4-H check-in.

6. Livestock stalls are primarily for the use of 4-H/FFA exhibits. Please check with Jenilee Godsey at the time of pre-entry to see if stalls are available for use of open class livestock. (If stalls are used, the exhibitor is responsible for cleaning during and before their livestock may leave the fairgrounds. Check-out arrangements must be made with the Superintendent or County Agent. Up to \$100 of prize monies will be withheld if the livestock exhibitor does not clean up appropriately.

7. When livestock is judged, stress will be given to the winner in points, type, size, quality, symmetry, vigor, constitution, general characteristics of the various breeds, show conditions, action in horses, and fleshing qualities in beef cattle, horses, and sheep. One exception to this rule is the Bucket Calf project.

8. The Bucket Calf Project is for youth 12 years old and under. The bucket calf must be an orphan, born after January 1 of the current year, and must be halter broke. The judging will be based on the exhibitor's knowledge of raising the calf, nutrition, care, health, and feeding. The confirmation of the calf will not be judged. Only one bucket calf per participant.

9. All animals will be shown to halter and brought out to the section of the grounds upon which the judging is being done. Do not ask the judge to place ribbons upon animals in the pens, except where there is no competition.

10. In addition to premium monies, ribbons will be given in each class.

GRAHAM COUNTY FAIR ASSOCIATION RULES AND REGULATIONS

Rule 1.

Section 1. The Graham County Fair reserves to the Fair Board the final and absolute right to interpret these rules and regulations and to arbitrate, settle, and determine, all matters, questions, and differences in regard to or otherwise arising out of, connected with, or incident to the Fair. Section 2. The management reserves the right to amend and add to these rules as they in their judgment may deem advisable. In the event of conflict of General or Special Rules, the latter will govern.

Section 3. Any person who violates any of the following Special Rules shall forfeit all privileges and premiums and be subject to such penalty as the Board of Commissioners may order.

Section 4. The following Rules and Regulations will apply to each and every department of the Fair, and exhibitors and concessionaires are requested to familiarize themselves with all rules.

Section 5. All entries must be filed with the Secretary not later than the date and time specified. The management reserves the right to reject any entries offered. All exhibits must be on the grounds at the scheduled time for the exhibit area (see program for details).

Section 6. Every exhibit, except Livestock, must remain intact until 8:00 A.M. on the day after the Fair, and the failure to comply with this requirement will bar said exhibitors from participating in premiums which may have been awarded by the judge in any department of the Fair. No mailed entries will be returned from the Fair Office unless sufficient postage is sent for return mailing. All articles not called for five days after the closing of the Fair will become property of the Fair Association, unless otherwise arranged for with the Fair Board Secretary.

Section 7. All property of any character entered for competition, display or for any other

purpose or being anywhere in the Fairgrounds shall be subject to the control of the Secretary.

Section 8. In no case shall the Graham County Fair Association or its Board Members or any of their employees be held responsible for any loss, damage, accident, injury, or death from any cause of people or animals, or cars or machinery, disease included, of any character, while they or their property are on the Fairgrounds, at any time or place. Section 9. If the property owners or others interested in the property desire protection against loss, damage from injury against fire or from other causes, they must make their own arrangements and pay for such insurance.

Section 10. Stalls for livestock will be bedded free for beginning of the Fair. Exhibitors will be required to keep their places and stalls in a clean condition by removing from there any filth and litter from in front of and behind said pens and stalls and place them conveniently for the litter force of the management to gather up.

Section 11. If it be ascertained that any exhibitor or his employees have in an ungentlemanly manner taken exception to the judgment rulings of an awarded committee, judge, superintendent, or any official of the Graham County Fair, the Board of Commissioners can expel the exhibitor and employees so offending from competing for a premium or exhibiting on the grounds of the management until he has made proper apology and has been reinstated by a majority of the whole Board of Directors.

Section 12. If it is ascertained that an exhibitor has made or caused to be any false statement in regard to any animal or article or if any exhibitor attempts to interfere with the judges in the performance of their duties, he shall be excluded from competition on the grounds of the Association.

Section 13. The Superintendent shall exclude Livestock from competing should there be any unnecessary or embarrassing delay on the part of exhibitor in bringing the animals into the show ring.

Section 14. Exhibitors shall show their animals at such times and places as may be directed and shall furnish such information concerning their stock as may be required by the

Superintendent and the refusal to do so will result in the forfeiting of any and all claimed awards. Section 15. Special care will be taken that no animals having a communicable disease of any nature will enter the grounds at any time during the Fair. The Livestock Superintendents will refuse unloading privileges to any stock having diseases. Persons exhibiting Livestock will bear all expense or vaccinations where required by state regulations.

Section 16. Nothing shall be sold or given away or otherwise disposed of by exhibitors which may in any way conflict with or which is the subject matter of any privileges granted or sold by the Graham County Fair.

Rule 2. Claim Injury:

Section 1. No claims for injury to any person or property shall be asserted nor suit instituted or maintained against the Graham County Fair, its officers or their agents by or on behalf of any person, firm or corporation or their agents, representatives, servants, or employees having license or privileges to exhibit on the Fairgrounds or occupy any space thereon.

Section 2. If any damage, loss or injury of property shall be approximately caused by reason of neglect or willful act of any person, firm, corporation, their agents or representatives, servants or employees having license or privilege to exhibit on said Fairgrounds or occupy space there, the Graham County Fair shall not in any manner be responsible therefor and in case it be subject to any expense or liability all persons causing same are liable therefor and shall indemnify the

Graham County Fair at Hill City, Kansas.

Rule 3. Removal of Objectionable Exhibits and Displays:

Section 1. The management reserves the right to remove from the grounds any exhibit, animal, concession, or show that may be falsely entered or may have any sign, banner, or advertising matter of any kind which may be deemed unsuitable or objectionable by them without assigning a reason thereof and if necessary return any money already paid for space for stalls which shall exonerate them from any claim whatsoever on the part of the exhibitor or purchaser.

Rule 4. Granting of Privileges:

Section 1. The Graham County Fair Board authorizes the letting of only such privileges and concessions as are necessary to supply the wants of the people or that may add to their comfort, convenience, or pleasure, but under no circumstances will a privilege of a questionable nature or of a demoralizing tendency be let, or in any manner tolerated where the business is conducted in any other than a legitimate and trade like manner.

Section 2. Parties desiring to purchase privileges can do so at any time on application to the Fair Board or at the Fairgrounds on or before the first day of the Fair.

Section 3. All space allotted must be improved and decorated by the purchaser at his own expense.

Section 4. All light and power used shall be paid for by concessionaires and commercial exhibitors. The Association reserves the right to place a meter on any and all lines where in its judgment it is to their advantage to do so and where the current consumer totals more than claimed. Exhibitor must pay for installing his own lights.

Section 5. Each concession must confine himself to the space assigned. Failure to do so will subject him to forfeiture of his privilege.

Section 6. The Board of Directors will use every precaution to guard against extortion of any form practiced upon patrons of the Fair. A violation of this rule by any concessionaire will cause the forfeiture of contract and money paid, or expulsion from the grounds, or both, as the management or superintendent may direct.

Rule 5. Access:

Section 1. Any official representative of the Graham County Fair shall have access to the premises of any exhibitor or concessionaire at any and all times.
